



# 夯实治理基石

# Laying a Solid Foundation for Corporate Governance

华宝信托建立权责明晰、管理科学的治理体系,不断提升行业监管自律水平,在社会责任管理方面积极探索 与实践,走出一条可持续发展道路。

Hwabao Trust has built up an accountable and scientific governance system, constantly strengthens its industry monitoring and self-discipline, actively explores best practices in corporate social responsibilities, and has embarked on a journey of sustainable development.

### 优化治理结构

Optimizing Governance Structure 公司按照《公司法》《信托法》等有关法律法规的规定和国家金融监督管理总局的监管要求,建立股东会、董事会、监事会和经营管理层相互分离、相互制衡的公司治理结构,强化职责、完善流程、规范运作。2023年,公司修订完善《重大事项决策权责清单(试行)》《董事会议事规则》等制度,进一步规范决策行为。

In accordance with the provisions of the *Company Law*, the *Trust Law* and other relevant laws and regulations and the regulatory requirements of the National Financial Regulatory Administration, the Company has established a corporate governance structure in which the shareholders' meeting, the board of directors, the board of supervisors and the management team are separated from each other and are subject to checks and balances, so as to strengthen accountability, streamline processes and standardize operations of the Company. In 2023, the Company revised the *List of Major Decision-making Related Authorities and Responsibilities (a Trial Version), Rules of Procedure of the Board of Directors* and other systems to further standardize the decision-making process of the Company.

# 完善董事会 制度建设

Improving the board system

董事会由 9 名董事组成,其中独立董事 3 名。在董事会成员构成方面,公司充分考虑性别、年龄、文化及教育背景、专业技能等方面因素,保障董事会成员构成多元。各独立董事利用自身专业知识和经验对公司的经营管理和投资决策提出意见、建议,并对公司的重大事项发表独立意见,充分发挥独立董事的作用。

The board of directors consists of nine directors, including three independent directors. The company fully considers gender, age, cultural and educational backgrounds, professional skills and other factors to ensure diversity in the board's composition. Each independent director shall exercise his or her professional knowledge and experience to put forward opinions and suggestions on the company's operation, management and investment decisions, and express independent opinions on major matters of the company, hence giving full play to the role of independent directors.

# 强化行业 监管自律

Strengthening Industry Supervision and Selfdiscipline 公司不断增强员工的行业监管自律意识,积极参与行业法制建设,持续发布合规报告、法规速递、资管产品分析等各类宣贯文件。2023年,公司对《关于规范信托公司信托业务分类的通知》《信托公司监管评级与分级分类监管暂行办法》等法律法规及各项监管政策性文件及时解读,准确把握要求;同监管部门沟通交流,对各项监管要求及时提出公司意见及建议。


