



Hwabao Trust continuously enhances its governance mechanisms, deepens the industry self-discipline practices, strictly fulfills the obligation of information disclosure, and simultaneously strengthens corporate social responsibility management, thereby comprehensively advancing the governance standards of a modern financial enterprise.

## 优化治理体系

Optimizing the governance system

公司积极落实"三重一大"决策制度,结合公司实际情况,修订《重大事项决策权责清单》,明确各决策主体的责任;完善《董事会授权管理制度》和《董事会授权决策方案》,构建规范的授权体系;通过优化董事长专题会和总经理办公会的会议管理制度,确保会议高效运作,并修订基本业务授权书,适配公司的战略规划和业务拓展。公司对各专业领域的"1+N"制度文件框架进行细致梳理,形成《华宝信托制度树(2024版)》。

The Company actively implemented the "Three Majors and One Large" decision-making system, which requires collective deliberation on major matters, appointments and dismissals of key personnel, significant project arrangements, and large financial expenditures. In alignment with its actual operations, the Company revised the *List of Rights and Responsibilities for Making Decisions on Major Matters* to clarify the responsibilities of each decision-making body. It also improved the *Rules for Authorization by Board of Directors and the Standard Procedures for Authorization by Board of Directors*, establishing a standardized authorization framework. Further, the Company optimized the meeting management systems for the Chairman's special meetings and the General Manager's office meetings to ensure operational efficiency. It also updated the basic business letters of authorization to align with the Company's strategic planning and business expansion. Additionally, Hwabao Trust systematically reviewed its internal rules and regulations based on the "1+N" framework for various professional areas, and produced the *Hwabao Trust's Tree of Internal Rules and Regulations (2024 Edition)*.

## 完善董事会 建设

Refining the Board of Directors

公司按照《中华人民共和国公司法》《中华人民共和国信托法》《信托公司管理办法》及《信托公司治理指引》等有关法律法规的规定和国家金融监督管理总局的监管要求,建立了股东会、董事会、监事会和经营管理层相互分离、相互制衡的公司治理结构,强化职责、完善流程、规范运作。截至2024年年末,董事会成员共9名,其中独立董事3名。

In accordance with the Company Law of the People's Republic of China, the Trust Law of the People's Republic of China, the Rules Governing Trust Companies, the Guidelines for the Governance of Trust Companies and other applicable laws and regulations, as well as the supervision requirements of the National Financial Regulatory Administration, the Company has established a corporate governance structure featuring a clear separation and mutual checks and balances among the General Meeting of Shareholders, the Board of Directors, the Board of Supervisors and the Executive Management. This structure strengthens accountability, streamlines processes, and ensures standardized operations. By the end of 2024, the Board of Directors consisted of nine members, including three independent directors.

The Company continued to issue various regulatory communications, including regulatory updates and policy compilations, to enhance employees' legal knowledge and compliance awareness, and actively participated in promoting a rule-of-law-based industry environment. In 2024, the Company promptly interpreted all applicable laws, regulations and regulatory policy documents, such as the Anti-Money Laundering Law of the People's Republic of China, the Rules for Compliance Management of Financial Institutions, the Rules for Addressing Criminal Cases Involving Financial Institutions, and the Notice of the National Financial Regulatory Administration on Matters Related to the Alignment of Corporate Governance Supervision Regulations with the Company Law. It also offered legal and compliance advice to ensure prompt and effective implementation of regulatory requirements.



Hwabao Trust adheres to the principle of "compliance first, risk control as priority" and contributes to strengthen its compliance and risk control system. By improving management mechanisms, refining internal control processes, enhancing risk prevention measures, and strictly implementing anti-money laundering requirements, the Company has laid a solid foundation for steady and sound development.

## 合规管理

Compliance management

The Company strictly implements the concept of creating value based on compliance management. Efforts are focused on supporting business transformation and development, improving compliance management system, and mitigating legal and compliance risks. While consistently meeting regulatory requirements and supervisory expectations, the Company actively ensures that all business activities are carried out in a lawful and compliant manner. In 2024, the Company organized 13 compliance training sessions and actively pursued ISO 37301 Compliance Management System Certification.

The Company attaches great importance to the construction of its internal control system, adheres to the principle of "harmonizing comprehensiveness with focus, check-and-balance with cooperation, authority with adaptability, and effective control with reasonable cost", the Company has established an internal control framework with clear responsibilities, defined roles, and mutual oversight. It has clarified the duties of the Board of Directors, the Board of Supervisors, senior management, and all departments. In addition, the Company issued the *Internal Control Evaluation Standards*, organized internal control self-assessment, rectified identified issues, and continuously optimized the internal control system to ensure alignment with business development needs.

## 风险管理

The Company strictly implemented its internal anti-money laundering and counter-terrorism financing rules and regulations, including the *Rules for Managing Anti-Money Laundering And Counter-Terrorist Financing Work*; revised its core internal rules and regulations, such as the *Regulations on Assessment of Anti-Money Laundering and Counter-Terrorist Financing Risks and Classification Based Management of Customer Risks*; required each business department to establish dedicated anti-money laundering positions and achieve risk classification, blacklist monitoring and other functions relying on the "anti-money laundering system"; and organized anti-money laundering training to continuously strengthen employees' awareness and capabilities in anti-money laundering across the organization.



The green note received a G1 rating, the highest possible grade.




